

TRANSFER CREDIT AGREEMENT
Between
Bethel University
And
GEORGIA NORTHWESTERN TECHNICAL COLLEGE

This agreement establishes the guidelines under which students who graduate from Georgia Northwestern Technical College with an Associate Degree may transfer to Bethel University:

1. Maintain a Bethel University/Georgia Northwestern Technical College Coordination Committee comprised of representatives from both institutions that will determine a regular review cycle for the purpose of examining the syllabi for transferable courses, validating faculty credentials, and monitoring cooperative administrative processes for admission, financial aid, and academic records.
2. Hold meetings as required by the Commission on Colleges of the Southern Association of Colleges and Schools of the Coordination Committee under the administrative supervision of the Chief Academic Officer at Bethel University to review the syllabi, faculty credentials, and administrative processes. Annually, the chief academic officers of each institution will be responsible for providing an updated evaluation report of the transfer program to the Coordination Committee at its summer meeting.
3. Acknowledge that the Chief Academic Officer of Bethel University is to be administratively responsible for the oversight and coordination of this transfer program. Annually, the chief academic officer of Georgia Northwestern Technical College will provide the Chief Academic Officer of Bethel University with a copy of each new faculty member's file from TCSG for those faculty teaching courses that are transferable to Bethel University. The Chief Academic Officer at Bethel University will maintain these files with a notation in the files stating where the originals can be found and what courses the faculty members are eligible to teach.
4. Agree to award transfer credit for the following programs taught by the designated instructors:



5. Students must satisfy the admission requirements of Bethel University, and its applicable program(s). Bethel University will evaluate each applicant and accept or reject the applicant based on established admissions policies.
6. Any additional courses considered for transfer from Georgia Northwestern Technical College to Bethel University must be reviewed for collegiate content and faculty credentials by the Coordination Committee under the administrative supervision of the Chief Academic Officer of Bethel University.
7. Students who have completed the Associate of Applied Science degree in the degrees mentioned above will be granted up to 80 semester credit hours toward the Bachelor of Science in Management and Organizational Development as applicable to Associate of Applied Science degree. This Articulation applies *only* to students in the program, and in the event the student leaves these programs, the student's transcripts will be reviewed on a course-by-course basis for credit transferability.

This Agreement is entered into for winter quarter 2010. This agreement may be amended at any time by mutual written consent of both parties. This agreement may also be cancelled at any time by either party with at least ninety (90) days written notice to the other party. If this Agreement is cancelled, Georgia Northwestern Technical College and Bethel University will work together to ensure that students currently applying to Bethel University will have an opportunity to transfer their courses.


